NOTE: Altered Group competition placements 1st-4th will be offered. Altered Group winners will advance to Altered Best in Show.

Best in Show Judges to be announced immediately prior to the judging of Best in Show.

Entry Limits: Obedience entries will be limited to 30 per day. Rally Obedience entries will be limited to 70 per day.

Non-Licensed Classes: Non-Licensed Veteran will be offered in Show 1 on Saturday and Puppy classes will be offered in Show 1 on Saturday and will show after the licensed classes for their breed. Breed winners will automatically advance to Best Veteran/Puppy in Show competition. The cost of entry is \$10. Dogs do not need to be permanently registered with UKC or have a Temporary Listing (TL) number to compete in Novice Puppy.

Total Dog®/Total Junior: Offered each day. To qualify, exhibitors need at least one Conformation win and one performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award.

Total Dog Invitational Qualifying Event! Any dog that earns a Total Dog at the 2025 Midwest Classic will automatically qualify to enter the Total Dog Invitational event to be held in Fall of 2025 to compete for a grand prize of \$10,000!

ENTRY FEES

Pre-Entries must be submitted via UKC's online entry system. Pre-entries will open on Monday January 6, 2025, at 8:00 a.m. Eastern time. All pre-entries must be submitted by Sunday, February 3, 2025, 11:59 p.m. Eastern time. No entries will be accepted or processed after that time.

SHOW & TRIAL TIMES

Show/trial judging times will be published in the Midwest Classic Judging Program. The building will open at 7 a.m. Friday – Sunday and close 30 minutes after judging has concluded. The building will open to exhibitors at 1:00 p.m. on Thursday and close at 5:00 p.m.

Conformation (First Bank Expo Hall - Indoor on carpet)

ENTRY CONFIRMATION

1. Receipt of payment for online entries will be emailed immediately.
2. Confirmation of processed entries will be emailed within three business days. Please verify the information provided is correct.
3. One armband will be assigned to each dog. Entry information will be printed on the back of the armband. Armbands will be made available for pick up at the event.

GENERAL INFORMATION

- This event is indoors. Conformation, Rally and Obedience will be in the First Bank Expo Hall. Nosework will be in the Exhibit Building.
- Please remember to keep all grooming to a minimum per UKC rules.
- The use of items such as dye, hairspray, chalk, powder, aerosol sprays, dry shampoo and other such grooming products is strictly prohibited.
- Overnight security is not provided, and no dog(s) may be left unattended overnight.
- All times are Eastern Standard Time.

- There will be absolutely NO SMOKING and NO VAPING in any building or within 25 feet of any building entrance.
- No general admission or parking fees will be charged.

FACILITY RULES AND SHOW GUIDELINES

- The building will be open to exhibitors Thursday from 1 – 5pm and 7am Friday – Sunday and will close 30 minutes after judging has concluded.
- Camping sites are available onsite for \$38 per night. Sites have either 50 or 30 amp but no water. Sites will be available on a first-come-first-served basis. Payment for camping will be available on the UKC website.
- The building set-up and show committee have complete authority over crating and grooming areas. Crating and grooming will be available on a first-come, first-served basis. There will be plenty of space available.
- No ex-pens will be allowed in the building for the use of relieving dogs.
- Bathing tubs will not be available.
- **Exhibitors are expected to clean up after their dogs.**
- Each exhibitor is responsible for clean conditions around his/her grooming areas – bring your broom, etc.

- Entries cancelled before the pre-entry deadline date and time will be charged a processing fee of \$3 per entered class.
- No refund of entry fees will be made for entries cancelled after the pre-entry closing date, except in the cases of females that come into season and are entered in a performance event.
