



# UNITED KENNEL CLUB **DISQUALIFIED FOR ATTACKING**

This form is only to be used when an attack or attempt to bite has occurred in the competition area or elsewhere on the event grounds.

When an incident occurs in the competition area or elsewhere on the event grounds, the dog must be disqualified by the judge or host club, and the exhibitor must remain on the premises until the "Disqualified for Attacking" report has been completed.

This form must be completed by the judge if the attack occurs inside the competition area. This form must be completed by the host club if the attack occurs anywhere on the event grounds other than the competition area.

This form must be completed by the judge as soon as possible after the incident, following any immediate medical attention that may be necessary. The incident and all pertinent information must be outlined in the space provided below or on an additional piece of paper and is to be submitted to UKC by fax or email within 72 hours of the event, with the completed form. The Event Chairperson is responsible to follow the procedures in notifying UKC of this incident and to provide the proper copies to the parties as outlined on this form.
