In addition to being familiar with the specific rules for the licensed event in which the applicant is seeking, the applicant must also be familiar with and agree to abide by the Rules and Regulations of the United Kennel Club, and the UKC Judges Code of Ethics.

I understand that all licenses to judge at UKC events shall be issued at the sole discretion of the United Kennel Club. A license may be suspended or revoked by UKC at any time at the sole discretion of UKC, with or without cause.
